Discussion

Information Session from Jon Passe, EPA

- EPA's recent RFI on ISO 17065 organizations becoming VOO's (Verification Oversight Organizations) for the Energy Star Homes Program. Summary below:
 - 10 years ago EPA operated with a handshake agreement with RESNET no other orgs could do what RESNET did.
 - o Another organization approached EPA expressed interest in working with EPA VOO was born.
 - About a year ago EPA approached by another organization stating that they met all criteria for VOO except that they are not a not-for-profit. Impartiality and avoiding conflict of interest primary reasons for this requirement. They are ISO 17065 and claim that this is a more appropriate status than VOO.
 - EPA has researched to understand better what ISO 17065 is all about in the past year.
 - EPA Products now operates under 17065 model for 3rd party verification.
 - o Enough merit in the inquiry to put RFI out for stakeholder comment.
 - Next steps for EPA could include: revised VOO application and revised certification standards.
 - Potential outcomes:
 - Do nothing based on potential negative feedback.
 - Expand eligibility to include ISO 17065 in addition to non-profit model (i.e. RESNET) and reserve the right to make further changes later.
 - Require ISO 17065 accreditation and put RESNET on a timeline to achieve this certification over time.
 - Example: NGBS. HIRL is an ISO 17065, and operates NGBS in a 17065-like format, but has not submitted the certification scheme to their certification body to have NGBS added as a 17065 process.
 - Earliest timeline for Revised VOO Application and Certification Scheme to take to 17065 certification bodies would be mid-2020. Lots of ifs between now and then.
 - Competitors in the ERI world could potentially come sooner. ANSI 380 and ANSI 301 exist now for someone to take to a certification body.

- Per RESNET Pending Standard Amendments report, there were 5 proposed standard amendments open for comment. 3 were reviewed during the August Standards meeting. The relevant documents can be accessed by opening the attached report and clicking on the appropriate link.
 - o Minimum Rated Features Insulation Installation Grading: No comments were issued.
 - National Water Rating Index: No comments were issued.
 - Duct Leak to outside Test Exception: We issued one comment disagreeing with Comment #1, who
 advocated for the elimination of DLTO as inappropriate in attached dwelling units. We supported
 the inclusion of DLTO and recommended that the current proposed language be kept unchanged.
 - o Thermal Distribution System Efficiency (DSE): No comments were issued.
 - Standard for Testing Airtightness of Building...: No comments were issued.
- Added by Frank: Draft PDS-02, BSR/RESNET/ICC 301-2014 Addendum N-201x, Normative Appendix B is now open with an end date for comment of October 29th. This is the second go round on proposed changes to requirements for the inspection and documentation of minimum rated features (photos, geotagging, etc.). This will be discussed during our next meeting.

Training Management (Bruce Bennett)

- Status report on currently running online training class. Feedback from Betsy and Frank is that material is behind schedule and quality is not as expected. Communication from The BER has not been proactive. We are proceeding to provide the best training we can and address quality issues with The BER on a timely basis.
 We should be prepared to deal with customer complaints.
