Addendum 1 – Basement Rating Guidelines

In: Section 4.6.b.8 (1): Defining Conditioned and Unconditioned Spaces

Basements in particular are a challenging space to define as either conditioned or unconditioned. The chart below, developed by Peter Harding of Home Energy Technologies, clearly defines under what circumstances a basement is considered conditioned or unconditioned and when to include volume and/or conditioned floor area in the rating file.

If the actual Btu/hr of air registers in an unfinished space is unknown the space shall be excluded from the CFA if the supply air flow is < 15 CFM/100sf.
